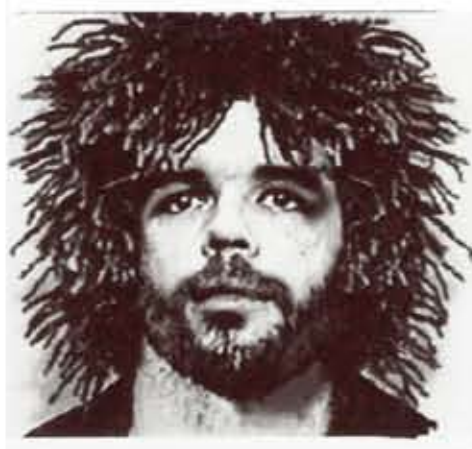
# \$50,000 REWARD

A \$50,000 Reward is being offered in the following two cases:

1. On November 10, 1993 at approximately 12:30 a.m. a 19 year old woman was walking along Dundas Street East near Poulette Street in the city of Toronto. At that time, it is alleged that a man approached her, brandished a knife and led her onto Poulette Street. The man dragged her under a parked tractor trailer where she was assaulted both physically and sexually. She was also robbed of her knapsack containing her wallet and school books. The woman assisted the Toronto Police Service's forensic artist in producing a composite sketch of the man.
2. On July 3, 1994 at approximately 2:55 a.m., in the Queen Street West and Bathurst Street area, a man allegedly climbed to the second storey apartment of a 46 year old woman. While inside, it is alleged that he attacked the woman and indicated that he had a knife. He then sexually assaulted her and robbed her of her purse.

The forensic evidence in the above investigations has conclusively shown that the same man is responsible for both crimes. He has never been identified.

**In 1993, the man was described as: either white or biracial, 18-25 years old, bushy brown hair in short dreadlocks, moustache and beard. He had small hands. He was wearing a multi-coloured Kangaroo style hooded jacket and running shoes. He was armed with a knife.**

CLAIMS WILL BE RECOGNIZED ONLY WHEN MADE IN WRITING PRIOR TO THE EXPIRY DATE.*
